Terms & Conditions of BMX rental



Article 1 Object

This document aims to define the conditions and civil responsabilities of clients who celebrate with the commercial company Blacksand, Lda NIPC 513283080, headquartered in Rua de Lisboa nº. 53-F, 9500-216 Ponta Delgada, temporary contracts for a limited period to rent and use BMX.

Article 2 General Provisions

BMX to rent to costumers by Blacksand, Lda are the exclusive property of this company, and are designed for the recreational use within the BlackSandBox enclosure.

Article 3 Terms of Rental

- 1) The rental of BMX works according to the timetable and rate operating in BlackSandBox.
- 2) In order the rental takes place, this document should be signed by the customer.
- 3) The client should always make prudent use of the BMX in order to maintain its preservation, operation and safety.
- 4) You can not transport other people in rented BMX nor cede it to third parties.
- 5) Blacksand, Lda reserves the right to refuse BMX rental to: a) who does not possess valid documentation; b) who proves visibly under the influence of alcohol or other substance; c) who does not provide assurance of prudent use and care of the bike; d) who previously has violated the rental conditions.

Article 4 Devolution

- 1) The customer must deliver the rented BMX as soon as the rental period expires, under the condition of not doing so having to pay the amount according to the existing price table, available for consultation on BlackSandBox.
- 2) If the return is made before the expiration of the lease time, the client will not be refunded of any importance.
- 3) Failure to return the rented BMX will be the subject of criminal complaint against the customer for committing a theft.
- 4) If the BMX is stolen from the customer, the customer shall submit a criminal complaint immediately to the police, and is responsible for the payment of its value, which amounts to €300.
- 5) The customer will be liable for any damage caused to the leased equipment, especially in the event of an accident, and should compensate Blacksand, Lda in the necessary amount for the full repair, according to price list available for consultation in BlackSandBox.
